Door Supervisors and Security Attendants at all times when on duty will wear an identity badge, conspicuously displayed and in a form and manner prescribed by the SIA.</li> <li>2. CCTV shall be provided in the form of a recordable system, capable of providing pictures of EVIDENTIAL QUALITY in all lighting conditions particularly facial recognition. Cameras shall encompass all ingress and egress to the premises and all areas where the sale/supply of alcohol occurs. Equipment shall be maintained in good working order correctly timed &amp; date stamped; recordings shall be kept in date order, numbered consequentially and kept for a period of 31 days and handed to Police on request. The Recording equipment and tapes shall be kept in a secure environment under the control of the Licensee or other responsible named individual. Appropriate signage representative of the above shall be placed in conspicuous positions</li> <li>3. Customers shall be actively encouraged to leave the premises quietly.</li> <li>4. Children accompanied by an adult, shall be allowed on the premises until 19.30 after which time no children shall be allowed on the premises.</li> <li>5. All windows and doors will remain closed from 21:00 onwards to abate noise pollution.</li> <li>6. The outside drinking area will not be used after 23:00</li> <li>7.
