<p><b>Reason(s) for special urgency</b> Explain why it cannot be published in the Register of Key Decisions with 28 days notice</p>	<p>The expenditure will be funded from the Strategic Acquisitions budget. The Macdonald car park site is of strategic importance to the completion of the Mayfield development</p> <p>Under the terms of the agreement for the acquisition of the Macdonald car park, exchange is required to take place within 4 weeks of agreement of terms with completion within 4 weeks of exchange. An extension has already been secured to allow for the Council's governance procedures but any delay beyond the Executive meeting on 16<sup>th</sup> November could put the transaction in jeopardy.</p> <p>Not to secure the site would mean the potential loss of a key gateway site to the development</p>
