The standard review of the premises licence under section 51 Licensing Act 2003 is inappropriate due to length of time a standard review would take, there are serious concerns as to the serious violence which has occurred at the premises.

Greater Manchester Police (GMP) will say that the premises are associated with Serious Crime and Serious Disorder. Therefore due to the Serious Crime and Serious Disorder which has taken place at the premises GMP feel that it is

Serious crime is defined within the statutory guidance as per section 81(3)(a) and (b) of the Regulation of Investigatory Powers Act 2000, which states that the conduct constitutes an offence for which a person 21 years of age or over with no previous convictions could reasonably be expected to be sentenced to imprisonment for 3 years or more.

The premises are situated on Whitworth Street West in Manchester city centre and the premises licence was issued on 18/12/2012. The Premises Licence Holder (PLH) is YDS UK Trading Limited and the Designated Premises Supervisor (DPS) is Mr Yongzhi Shao who has held this position since January 2019.

The incident which has triggered this Summary Review is as follows:

At 0230 hours on Sunday 11th June 2023 GMP received a telephone call from a person who stated that there were 2 groups fighting on the road outside the premises.

Police officers attended at the premises and established that a male had been stabbed in the leg and the offenders had left the scene. A short time later the officers updated that another male had also been stabbed, this time in his back.

From the witness statement of one of the victims it has been established that a fight had taken place inside the premises involving the group of offenders and some other males and the victim and his friends had ended up becoming involved and the male who ended up with a stab wound to his back was punched by one of the offenders.

The victims have then made their way outside to the smoking area and the group of offenders have been standing in the middle of Whitworth Street. They have goaded the victims and as a result of this the victims have come out of the smoking area and confronted the group of males.

This has resulted in another fight taking place in the middle of the road and during this fight both the victims have received stab wounds which a doctor who later treated them said are consistent with knife injuries.

The male with the stab wound to his leg suffered heavy blood loss and the male with the stab wound to his back kept slipping in and out of conciousness.

A blood stained knife was later recovered nearby.

During the initial brawl inside the premises 2 females were caught up in it and received minor injuries and another male was punched in the face resulting in cuts and bruising and a laceration to his elbow.

This incident comes only 10 weeks after a male customer was slashed across the face in the premises resulting in a wound which required 30 stitches.

This previous knife incident resulted in Summary Review proceedings being instigated and GMP asking for suspension of the premises licence. Committee took the decision not to suspend the licence and attached an extra condition to the licence regarding the searching of all customers using knife

wands.

This condition became the final decision at the full review hearing.

2 reports of crime for a Section 18 Wounding with Intent have been submitted as well as a crime for ABH and 2 crimes for Common Assault and enquiries are ongoing to trace those responsible.

GMP have serious concerns as to the level of violence which occurred at the premises and by the fact the offenders were able to enter the premises carrying a knife in the first place. More so now that they have a condition requiring them to search all customers using knife wands.

The powers contained under section 53A of the Licensing Act 2003 are necessary and proportionate in light of the association that the premises has to Serious Crime and Serious Disorder.

In the interim Greater Manchester Police would request that the Licensing Authority consider suspension of the Premises Licence until the full review is heard before the committee. Serious Crime and Serious Disorder has occurred at the premises and until the Licensing Committee hear the full review and all the evidence that will be disclosed, to allow the premises to continue to operate as a licensed premises gives concerns that further violent incidents will occur at the premises and the safety of both customers and staff will be placed in jeopardy.

Greater Manchester Police will say that the licensing objectives of the prevention of crime and disorder can only be promoted if the premises licence was supsended until the final determination of the summary review application.

The standard review of the premises licence under section 51 Licensing Act 2003 is inappropriate due to length of time a standard review would take. There are serious concerns as to the extreme level of violence that has occurred. Greater Manchester Police believe that Serious crime and Serious Disorder has occurred at the premises.

- conduct that amounts to one or more criminal offences and involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.

Serious disorder is not defined in legislation, and so bears its ordinary English meaning.
