Good afternoon,

Thank you for your previous e-mails on this issue. I think it may help if I try to answer your representation point by point.

Prevention of Crime and disorder.

The applicant agrees to doors staff at the rate suggested and is happy for this to be added.

The handling of CCTV recordings is also dealt with in some detail in the application. The information in the application was provided to myself by GMP as an accepted by GMP in may applications previously. I hope you will agree the wording is extremely similar, however the applicant is happy for the wording to be added.

Public Safety

I have attached the previous premise licence for this building (Wonder Inn). I hope you will agree the hours granted are in accordance with the hours requested in the current application. I am not aware of any conditions on the licence regarding foot traffic into and out of the building. I understand public safety is one of the conditions, but I'm unsure to what extent my applicant is responsible for the pedestrians on the public highway. If this pavement is deemed too narrow I would expect it to be dealt with by the highways department. Can I ask that you to consider that if this building was to be used for any other commercial purpose the width of the pavement wouldn't be taken into consideration, regardless of how many people were expected to use the venue. To impose such a condition would render the building useless an income stream for any landlord.

Prevention of public nuisance

Again, I understand the concern for the need to control music egress from the building. The premise is adjacent to spare land to one side, commercial property to the other and to the rear there is a carpark. The only residential property is to the rear left corner of the premise and is located on the first floor. The first floor of the premise will have double glazing to all windows. No windows will be open during the hours for recorded music. At present use of the first floor is still under discussion as to when the first floor will be operational. This is not expected to be within the first 6-8 months. Further information regarding public nuisance is detailed at the foot of this e-mail.

The protection of children from harm.

All Children under the age of 18 will be off the premise by 21.00. at all times children under 16 must be accompanied by an adult.


Please accept my apologies. This is a typographical error on my part. There is no second applicant.

GMP make reference to the hours requested for the retail sale of alcohol and that this will lead to intoxicated customers by 12.00 noon. I am unsure why this premise starting to sell alcohol at 10.00 will automatically lead to this. I have attached two licences for two premises on Dantzic Street along with a screen shot in relation to Casa Mia. The Seven Stars(J.D Wetherspoons) and Walkabout are next door to each other, the entrance to the printworks complex is also on Dantzic street. Both of these premises have earlier hours for the commencement for retails sale of alcohol one has the same terminal hour, and on certain days of the year it has a terminal hour of 04.00 and a closing time of 05.00.

Directly opposite these bars is a residential complex (The James). I would suggest that the probability for noise nuisance, intoxicated customers, a risk to customers when leaving, and foot traffic in the road is far greater here than the proposed licence for Casa Mia.

I hope the information is enough for you both to reconsider you representation.

$$P = D + (D \times V)$$

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

- (3) Where the permitted price given by paragraph (2)(b) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (a) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 6. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise):
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

 - (2) For the purposes of the condition set out in (1) above-
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

- (4) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 6. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective:
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

Annex 2 – Conditions consistent with the operating schedule

- A CCTV system shall be installed at the premises and maintained in good working order and used at all times when the premises are open for licensable activities. Ant CCTV footage shall be held for at least 28 days and shall be made available to an officer of the Licensing Authority or Police on reasonable request.
- 2. After 2100 on Fridays and Saturdays, SIA registered door supervisors shall be provided at a ratio of 1 per 100 customers. On all other days the need for door supervisors shall be assessed by way of a risk assessment and cognizance shall be taken of any police advice
- 3. A written record shall be kept on the premises by the Designated Premises Supervisor/Manager of every person employed on the premises as a door supervisor in a register kept for that purpose. That record shall contain the following details:

- 10. All doors and windows shall be kept closed after 2300, except for emergency (fire doors) and access/egress (non-fire doors).

- 12. Amplified music shall be kept at a level which does not cause nuisance to any nearby residential properties.
- 13. All bar staff shall receive appropriate training in relation to alcohol sales prior to commencing their duties. This shall include the premises licence conditions, underage sales policy and other relevant licensing matters. Training documents (which may be in an electronic format) shall be made available to an authorised Police officer or Licensing Authority officer upon request.

Annex 3 – Conditions attached after hearing by the licensing authority

Annex 2 – Conditions consistent with the operating schedule

- 1. The premises shall install and maintain a comprehensive digital colour CCTV system. All public areas of the licensed premises, including all public entry and exit points and the street environment will be covered, enabling facial identification of every person entering in any light condition. The CCTV cameras shall continually record whilst the premises are open to the public and recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public and must be able to produce / download / burn CCTV images upon request by a police officer or an authorised officer of the licensing authority. Any footage must be in a format so it can be played back on a standard personal computer or standard DVD player. Where the recording is on a removable medium (i.e. compact disc, flash card etc.), a secure storage system to store those recording mediums shall be provided.
- 2. Any queue to enter the premises which forms outside the premises shall be managed efficiently by venue staff so as to ensure that there is no public nuisance or obstruction to the public highway.
- 3. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 4. Whilst live or recorded music takes place, the licensee or management shall undertake regular monitoring of noise at the nearest noise sensitive locations. A record shall be kept of any monitoring including the date, time and location of monitoring; the name of the monitor; and any action taken. Records shall be kept for no less than 6 months and shall be made available upon request by a police officer or an authorised officer of Manchester City Council.
- 5. Staff shall monitor customers smoking outside the premises on a regular basis and ensure patrons do not cause a public nuisance.
- There shall be a documented dispersal policy as agreed with the relevant responsible authorities implemented at the premises and a copy lodged with the Council's Licensing Unit.

- 7. The premises licence holder shall ensure that the provision of door supervisors at the premises is appropriate to ensure the safe control of the premises, by undertaking risk assessments including estimated attendance and audience profiling of each event that has the provision of licensable activities. Documented records of training shall be kept for each member of staff. Training shall be refreshed at no greater than 6 monthly intervals. Training records shall be made available for inspection upon request by a police officer or an authorised officer of Manchester City Council.
- 10. The Designated Premises Supervisor shall ensure that a written notice of authority is kept at the premises for all staff who sell alcohol. The notice shall be made available for inspection upon request of the police or an authorised officer of the licensing authority and all staff selling alcohol must be in possession of formal identification to enable to verify their identity against the notice.
- 11. The Challenge 25 scheme must be operated to ensure that any person who appears to be under the age of 25 shall provide documented proof that he/she is over 18 years of age. Proof of age shall only comprise a passport, photo card driving licence, an EU/EEA national ID card or similar document, an HM Forces warrant card, or a card bearing the PASS hologram.
- 12. The premises licence holder shall ensure that alcohol is not sold to any person within the premises who appears to be intoxicated.
- 13. Security shall be employed when deemed necessary in the risk assessment which will be undertaken for each event upon event booking.
- 14. At least one member of the management team will be a registered first aider.
- 15. A safety plan shall be implemented that shall include fire safety.
- 16. The maximum occupancy of the premises as recommended by the fire authority and building control shall not be exceeded at any time.
- 17. The Event Management Plan drawn up for each event shall be available for inspection by any relevant authority upon request.
- 18. The premises shall operate a refusals book.
- 19. All under 18's must be accompanied by an adult at all times whilst on the premises.
