<ol style="list-style-type: none"> <li>1. A Challenge 25 policy will be strictly followed by all staff.</li> <li>2. Staff are trained as appropriate in respect of relevant licensing law.</li> <li>3. CCTV cameras are installed which will retain recording for a minimum of 31 Days.</li> <li>4. CCTV is installed inside and outside the premises. CCTV will be recording at all times the premises are open for any licensable activities and images will be held for a minimum of 31 days and made available immediately on request by any of the Responsible Authorities.</li> <li>5. The Premises License Holder will ensure that a trained member of staff will be on duty and be available to download the CCTV to any of the Responsible Authorities at any time licensable activities take place.</li> <li>6. The Designated Premises Supervisor and their staff will at all times remain aware of their responsibilities for the prevention of crime and disorder on the premises and demonstrate a responsible attitude to the marketing and sale of alcohol.</li> <li>7. Any person who appears drunk /aggressive will not be permitted on the premises.</li> <li>8. A challenge 25 policy shall be operated. No member of staff shall be permitted to sell alcohol until trained in the operation of the challenge 25 policy.</li> <li>9. A record of refusal shall be kept in the refusals register and kept on the premises. This will be made available to responsible authorities on request.</li> <li>10. All staff shall be trained on the four licensing objectives and a training record kept on the premises. The training record will be made available to responsible authorities on request.</li> <li>11. A fire alarm system will be installed to meet BS 5839 Part 1 current standards</li> <li>12. An emergency lighting system will be installed to meet BS 5266 current standards</li> <li>13. Firefighting equipment will be available in the premises to meet BS 5306 current standards.</li> <li>14. Floor staff will conduct physical sweep inside the premises to remove hazardous objects/waste as deemed necessary by the management.</li> <li>15. The Designated Premises Supervisor is aware of his responsibilities to the staff and customers in respect of public safety and will take all reasonable steps to ensure the maintenance of all provided safety arrangements and equipment in accordance</li> </ol>	N/A	Applicant

<p>with the requirements of current installations.</p> <p>16. Notices will be displayed at the exit of the premises asking patrons to leave the premises quietly.</p> <p>17. All deliveries will be conducted prior to 7pm to control noise nuisance.</p> <p>18. In conjunctions with the steps proposed for the prevention of crime and disorder objectives, the Licensees and staff will at all times remain responsible for the prevention of public nuisance in and around the premises.</p> <p>19. Facilities will be made available for customers to request a taxi. Customers will be asked to wait inside the restaurant until there taxi arrives to avoid public nuisance.</p> <p>20. The Designated Premises Supervisor and staff will at all times remain aware of their responsibilities under the objective, including that alcohol shall not be sold to anyone under the age of 18.</p> <p>21. Staff on duty have will be trained and made aware of these requirements and the need to demand an acceptable form of age ID.</p> <p>22. The premises will operate Challenge 25 policy.</p> <p>23. No adult entertainment is permitted at these premises.</p> <p>24. A refusals record will be kept at the premises which details all refusals to sell alcohol. The record will include the date and time of the incident, the name of the staff member who refused the sale, and the reason the sale was refused. All entries will be made within 24 hours of the refusal. The record will be made available for inspection by an officer of a Responsible Authority.</p>

The Challenge 25 scheme must be operated to ensure that any person who appears to be under the age of 25 shall provide documented proof that he/she is over 18 years of age. Proof of age shall only comprise a passport, photo card driving licence, an EU/EEA national ID card or similar document, an HM Forces warrant card, a card bearing the PASS hologram, or any electronic or biometric age verification technology approved by the licensing authority.</p>	<p>Yes (all)</p>	<p>Trading Standards</p>

<p>2. The premises shall display prominent signage indicating at any point of sale and at the entrance to the premises that the Challenge 25 scheme is in operation.</p> <p>3. The premises shall display prominent signage indicating at any point of sale and at the entrance to the premises that it is an offence to buy or attempt to buy alcohol for a person who is under 18 and for a person under the age of 18 to buy or attempt to buy alcohol.</p> <p>4. All staff authorised to sell alcohol shall be trained in:</p> <ul style="list-style-type: none"><li>a. Relevant age restrictions in respect of products</li><li>b. Prevent underage sales</li><li>c. Prevent proxy sales</li><li>d. Maintain the refusals log</li><li>e. Enter sales correctly on the tills so the prompts show as appropriate</li><li>f. Recognising signs of drunkenness and vulnerability</li><li>g. How overservice of alcohol impacts on the four objectives of the Licensing Act 2003</li><li>h. How to refuse service</li><li>i. The conditions in force under this licence.</li></ul> <p>5. Training must include evidence that the trainee has gained knowledge and understanding of the training, which may consist of a test or quiz, completed by the trainee.</p> <p>6. Documented records of training completed shall be kept for each member of staff. Training shall be regularly refreshed and at no greater than 6 monthly intervals. Training records shall be made available for inspection upon request by a police officer or an authorised officer of Manchester City Council</p>
