Annex 1 – Mandatory conditions

Door Supervisors

- 1. Only individuals licensed by the Security Industry Authority shall be used at the premises to undertake security activities, which include guarding against: -
 - (a) Unauthorised access or occupation (e.g. through door supervision),
 - (b) Outbreaks of disorder, or
 - (c) Damage,

unless otherwise entitled by virtue of section 4 of the Private Security Industry Act 2001 to carry out such activities.

Supply of alcohol

- 2. No supply of alcohol may be made under this premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence or,
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 3. Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either –

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 5. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price, which is less than the permitted price.
 - (2) For the purposes of the condition set out in (1) above-
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by paragraph (2)(b) would (apart from this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (a) Sub-paragraph (4)(b) applies where the permitted price given by paragraph (2)(b) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating schedule

- 1. Any person who looks or appears to be under the age of 21 shall be asked to provide ID to prove that they are over the age of 18.
- 2. Only the UK photo driving licence, passport or government approved PASS cards will be accepted as proof of age.
- 3. Posters will be on display in prominent locations in the shop advising customers of the Challenge 21 policy
- 4. Staff will be trained within the responsibilities of selling alcohol, which will include challenge 21 training. The training will be documented.
- 5. Spirits will be kept behind the counter
- 6. Alcohol will not be displayed near children's confectionery shelves.
- 7. Gas and electrical systems at the premises will be inspected and tested annually and appropriate certificates obtained
- 8. The licence holder will ensure compliance with the Regulatory Reform (Fire Safety Order) 2005.

Annex 3 – Conditions attached after a hearing by the licensing authority

- 1. CCTV will be in operation at the premises and all recordings will be kept on file for a minimum period of 31 days.
- 2. A notice will be displayed at the entrance of the premises advising that CCTV is in operation.
- 3. An alarm system with 24/7 accredited company monitoring will be installed.
- An incident book will be maintained at the premises showing full details of all occurrences of disorder and all refused alcohol sales at the premises will be recorded.
- 5. Conduct of customers will be monitored at all times to prevent behaviour such as loitering.
- 6. Signs will be displayed at the premises informing customers that the consumption of alcohol at the premises is not permitted at all times.
- 7. Signs will be displayed at the premises encouraging customers to dispose of their litter appropriately.
- 8. Strict policy not to serve drunken customers will be in operation at all times.
- 9. Notices will be displayed requesting that customers respect the neighbours and leave the premises quietly and maintain low levels of noise.
- 10. Shop front area will be well lit and covered by sufficient CCTV coverage.
- 11. Whole area covered by premises will be kept clean of any litter and rubbish and will make an application to the council to have a public litter bin placed at the front of the shop.
