What is the Decision	<p>(1) To extend a citywide Public Spaces Protection Order (PSPO), excluding the area covered by the existing city centre PSPO, in respect of alcohol consumption for a maximum of 3 years, to address anti-social behaviour associated with people drinking alcohol in public places.</p> <p>Article 1: Consumption of alcohol The consumption of alcohol or anything an Authorised Person or Constable considers to be alcohol in breach of an Authorised persons or Constables request to cease it's consumption.</p> <p>Article 2: Failure to surrender alcohol Having an unsealed container of alcohol or anything an Authorised person or Constable believes to be alcohol in breach of a request from an Authorised Person or Constable to surrender it .</p> <p>Requirement Article 3: Provision of information upon request A person who an Authorised Person or Constable reasonably suspects has breached Articles 1 or 2 of this Order shall, upon request of that Authorised Person or Constable, provide their name, address and date of birth to that Authorised Person or Constable.</p> <p>(2) To authorise the advertisement of Public Spaces Protection Orders (PSPOs) in respect of the area.</p>
Reasons for the decision (but excluding any exempt or confidential information)	<p>The Strategic Director (Neighbourhoods) is satisfied that the conditions as set out in section 60 of the Act have been met and that by extending the PSPO, this will prohibit and require specified activities be carried out by persons to ensure compliance with the Orders. In order to make the decision for the PSPO the following has been taken into consideration:</p> <ul style="list-style-type: none">• The evidence of the issues of concern• Consultation responses from the consultation undertaken from 16 September 24 to 13 October 24.
