To whom it may concern

I am contacting you on behalf of many of the residents in the Baytrees area of Harpurhey, m9 5xj. We wish to oppose the extension of the Opening Hours of chunky chicken, 789 Rochdale Road m9 5xj REF; 224848/hh1.

We feel that allowing the premises to stay open until 1am would attract people racing up and down our streets in the early hours in their cars, and to encourage more littering, noise and antisocial Behaviour that often go's hand in hand with the late night opening of take-away premises. It also need to be taken into consideration that behind these premise are residential properties with families with children living in them, and at night we can here customer using the premise and other passing by shouting and fighting and generally being a nuisance, we also have issues with customers and passers by entering the back of the premises and using the ally as a toilet, because he keeps the ally gates at the back of his premises open allowing access.

We have several problems the landlord of this property, regarding other properties he owns on the other blocks of shops, E.G. The cafe on the corner of Baywood street being used as a illegal gambling and drinking den, the hair dressers on the next block being used for the same purpose both without adequate emergency exit and augments and fights with weapons spilling out of the premises into Baywood street in the early hours of the mornings causing the residents to call the police as well as the flats above the cafe on the corner of Baywood street had to be condemned as unfit for human habitation and he was letting the 2 flats out to 13 people and many of them illegal immigrants.

We wish to oppose the extension of the opening hours of Chunky Chicken, 798 Roachdale Road Harpurhey m9 5xj . REF 22484/hh1.

We feel that the extension will bring more problems to this area if it is allowed to stay open until 1am.. We already have a lot of issues with the amount of littering, noise and anti-social behaviour that go's hand in hand with late night opening. It needs to be taken into consideration that just behind these premises are residential properties with lots of families. We already have issues with shouting, fighting and people generally causing a nuisance. Customers are using the ally way behind his shop as a toilet and this is access to peoples flats. There has already been a lot of problems with some of the other properties the landlord owns on the neighbouring row. E.G The cafe on the corner of Baywood street, is used as an illegal gambling and drinking den along with the hair dresser on the next row. Many times residents have had to call the police as fights have spilled out in the street in the early hours of the morning and weapons have been used. There is no real need for a take away to open so late.
