- the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 (S.I. 2012 No. 1464)
- Members' Personal Interests In Accordance With Paragraph 11.2 Of Manchester City Council's Code Of Conduct For Members

("my Partner"), where I am aware that my Partner has the disclosable personal interest.





This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992
