**Register of a Member's Disclosable
Pecuniary Interests**

Prepared in accordance with:

- Sections 30 And 31 of the Localism Act 2011
- the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 (S.I. 2012 No. 1464))
- Members' Personal Interests In Accordance With Paragraph 11.2 Of Manchester City Council's Code Of Conduct For Members

I, Jon-Connor Lyons, being a Member of Manchester City Council give notice that I have set out at PART 1 below under the appropriate heading the disclosable personal interests that I am required to notify to the Council's Monitoring Officer in accordance with Sections 30 and 31 of the Localism Act 2011 and The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and/or by virtue of Rule 29 of Manchester City Council's Procedure Rules and that I have set out at PART 2 below the personal interests which I am required to notify to the Council's Monitoring Officer under Paragraphs 11.1 and 11.2 of the Code of Conduct for Members adopted by Manchester City Council at its meeting on the 11 July 2012 and have put 'NONE' where I am not required to notify any disclosable personal interests or personal interests under any heading.

I am aware that in accordance with Section 30(3) of the Localism Act 2011, I am required to notify at PART 1 both my own disclosable personal interests and also any disclosable personal interests of

- (i) my spouse or civil partner,
- (ii) a person with whom I am living as husband and wife, or
- (iii) a person with whom I am living as if we were civil partners

("my Partner"), where I am aware that my Partner has the disclosable personal interest.

NB You must declare any payment or provision of any other financial benefit (other than from Manchester City Council) made or provided to you in respect of any expenses incurred by you in carrying out your duties as a councillor, or towards your election expenses, within the period of 12 months ending with the day on which you give your notification to the Council's Monitoring Officer for the purposes of Section 30(1) of the Localism Act 2011 and/or by virtue of Rule 29 of Manchester City Council's Procedure Rules. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992

3. Contracts with the council

- (i) either yourself or your Partner or

which are not fully discharged and which are contracts under which goods or services are to be provided or works are to be executed.

Please note that the reference to "securities" means "shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

4. Land in the area of the City Council

You should also include any property from which you or your Partner receive rent, or of which you or your Partner are the mortgagee

[NB You should list here any tenancies of properties of which you are aware, where the landlord is the City Council and the tenant is a body in which you or your Partner have a beneficial interest (being a firm in which you or your Partner is a partner, or a body corporate of which you or your Partner is a director, or in the securities of which you or your partner have a beneficial interest).

Please note that the reference to "securities" means "shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

Please note that the reference to "securities" means "shares, debentures, debenture stock, Loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society
