

## Manchester City Council's Code of Conduct for Members

# Register of a Member's Disclosable Pecuniary Interests

#### Prepared in accordance with:

- Sections 30 And 31 of the Localism Act 2011
- the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 (S.I. 2012 No. 1464))
